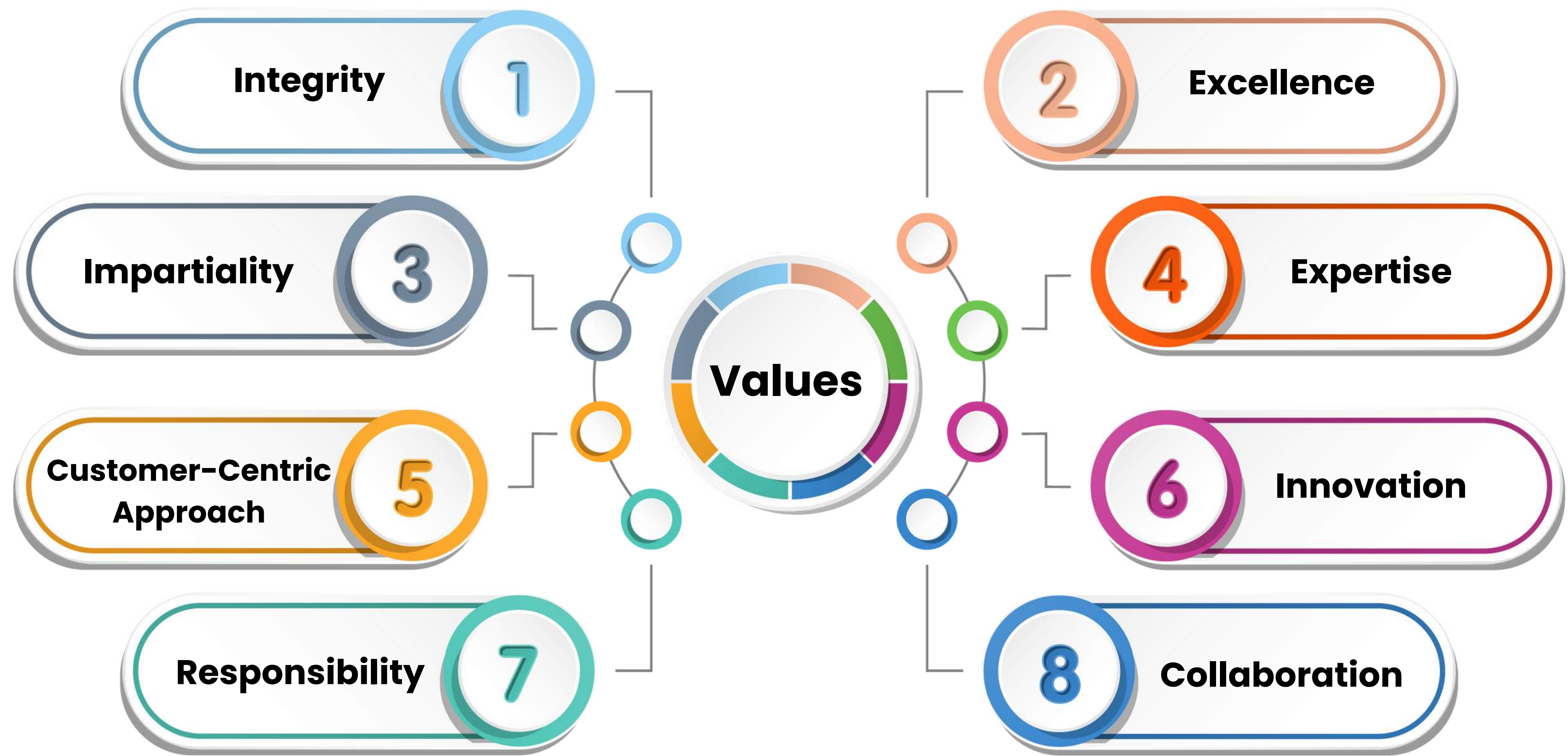

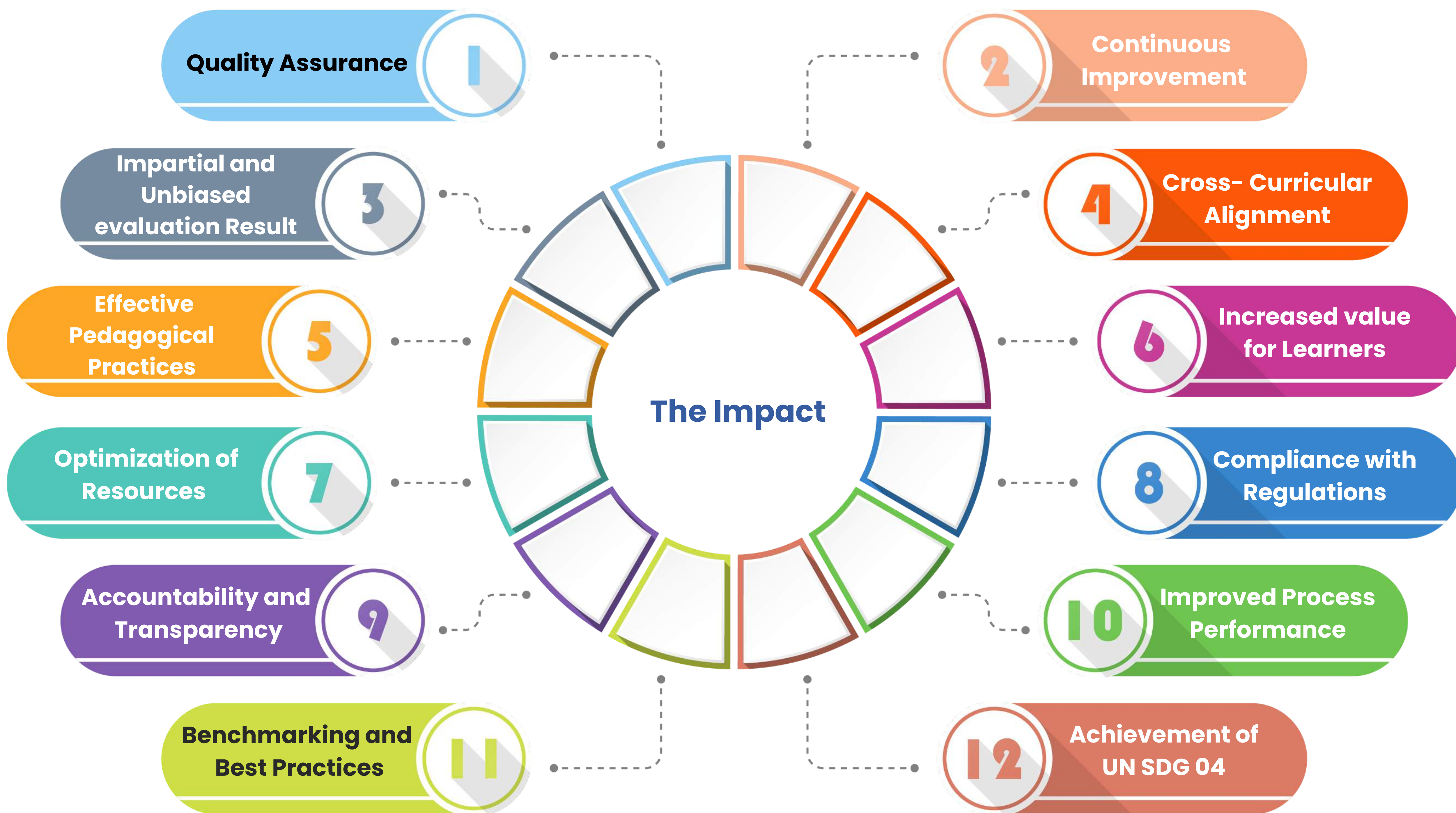

# Stages of Academic Audit

## Pre-audit Stages

**Stage - 1** Self- Assessment questionnaire to be filled up by each teacher

**Stage - 2** Students' feedback taken by COAE experts

## During -audit Stages

**Stage - 3** Orientation for all teachers before the start of evaluation exercise (30 minutes)

**Stage - 4** Classroom observation by COAE experts (each teacher is observed for one full period of 35 minutes during school hours)

**Stage - 5** One to one feedback meeting and interaction with teachers

**Stage - 6** Conduct of a common feedback session for all the teachers by the team of COAE experts for opportunities for improvements-  
On the last day, after the completion of the entire exercise

## Post-audit Stages

**Stage - 7** Preparation of detailed reports (teacher wise, level wise, grade wise, subject wise & executive summary for the whole school)

**Stage - 8** Presentation to the top management and leadership team of the school

**Stage - 9** Support in preparing the roadmap on the findings of academic audit

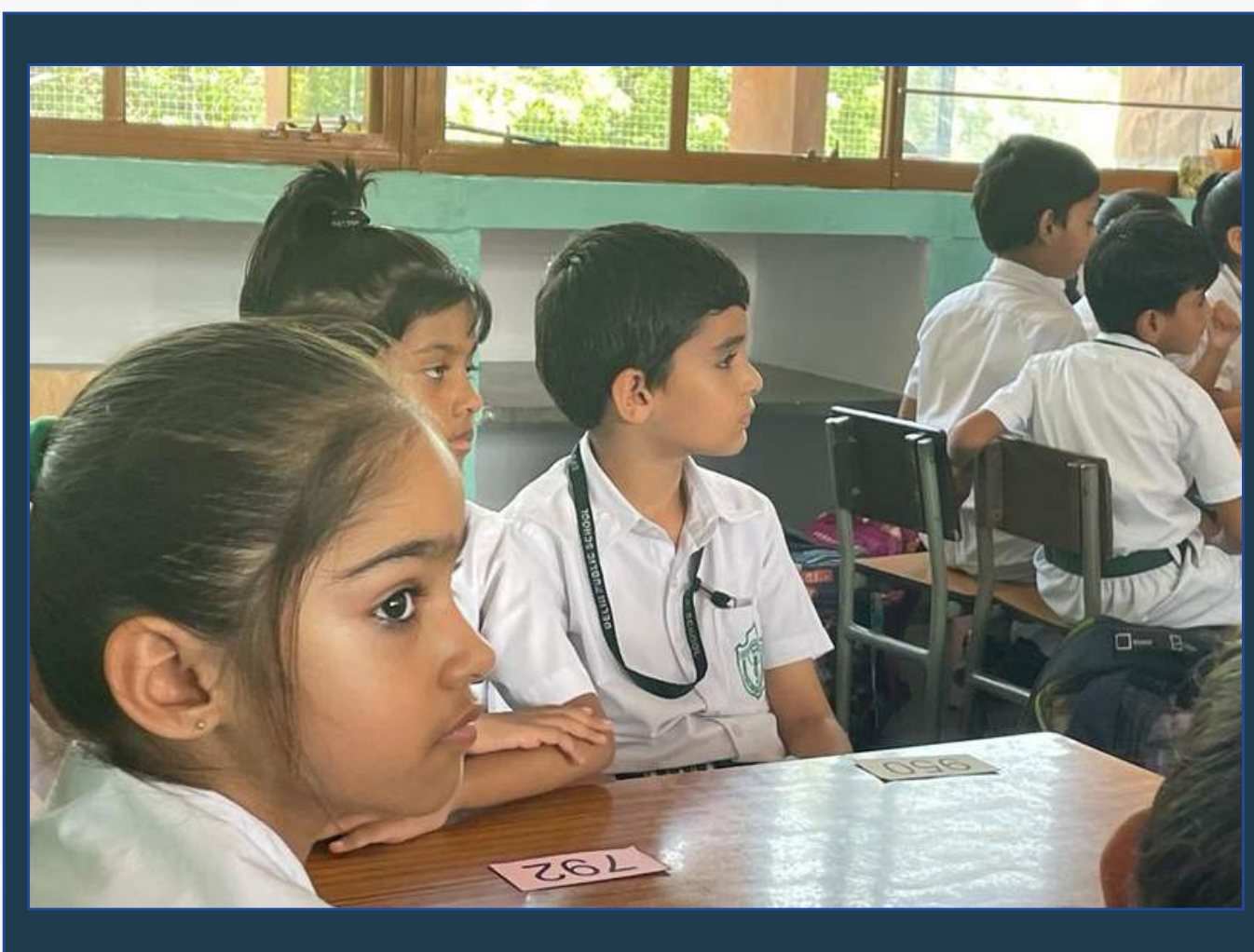
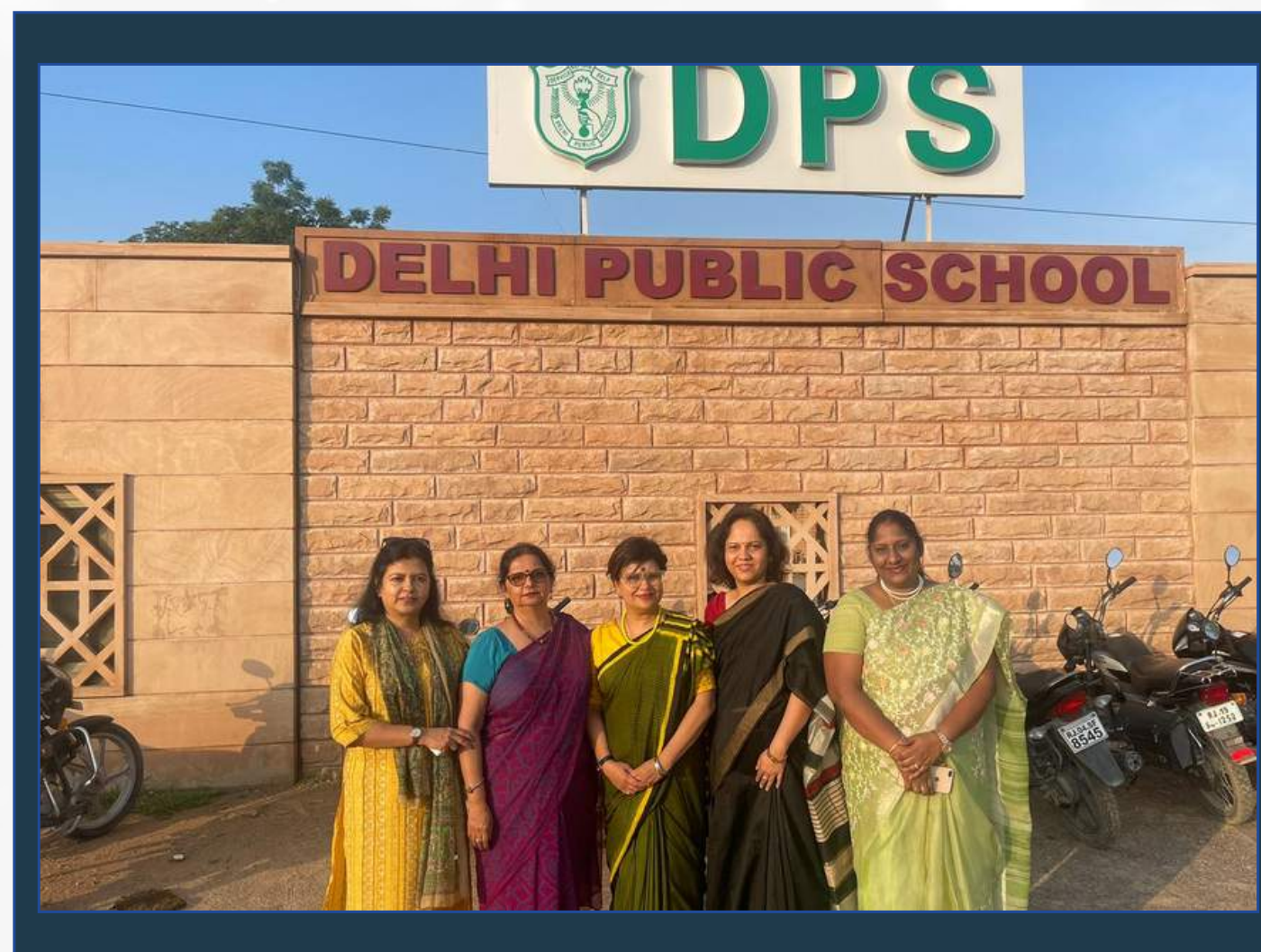
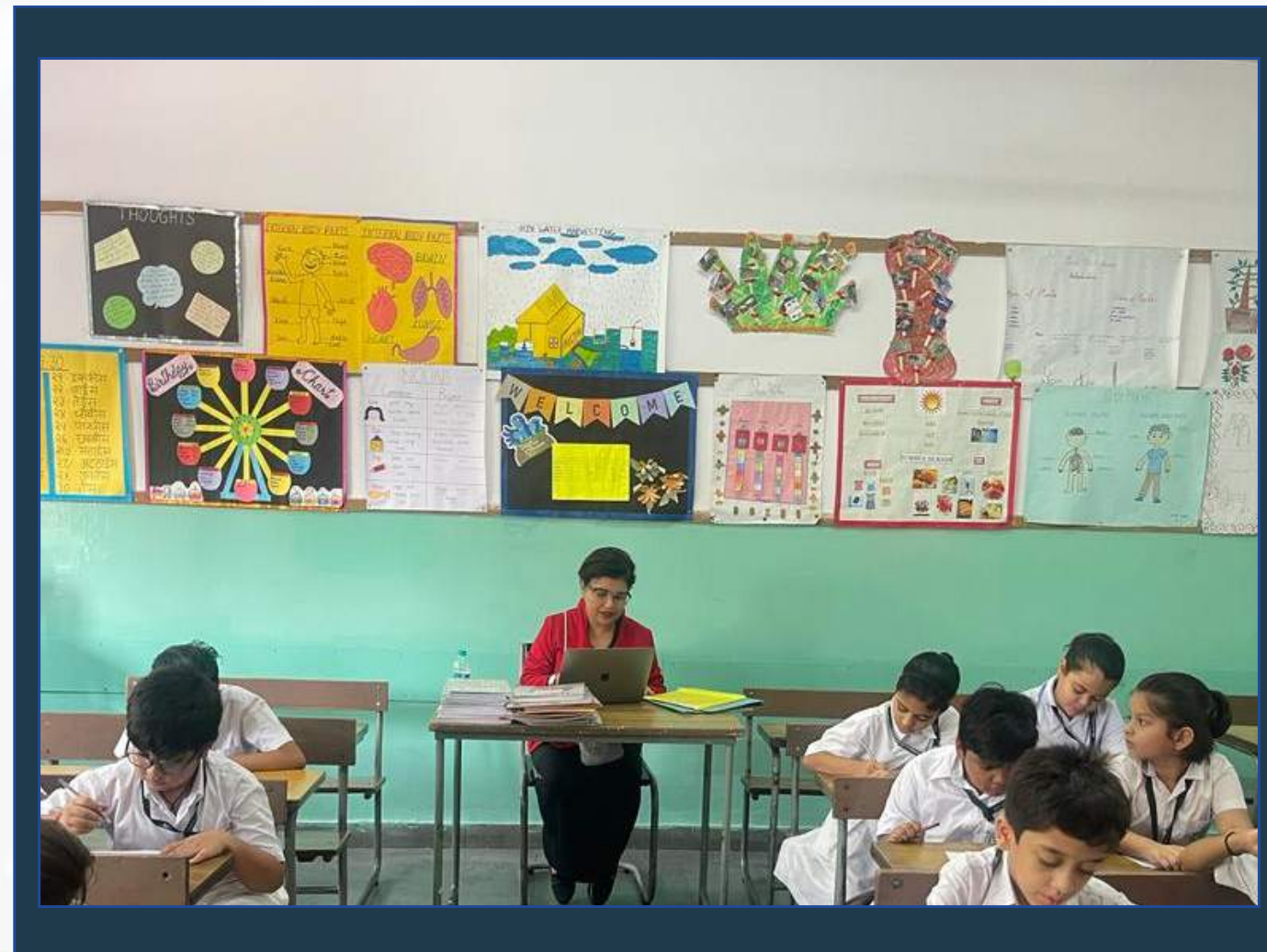
