Safeguarding the security and privacy of this data emerges as a paramount concern, especially in the current era marked by increasingly stringent data protection regulations.

CROSS-FUNCTIONAL COLLABORATION

Implementing ISO 21001 often necessitates collaboration among various departments and stakeholders within the institution. Effective communication and cooperation can be challenging in large, decentralized organizations.

ADAPTATION TO LOCAL CONTEXT

ISO 21001 is a global standard, but it needs to be adapted to the specific needs and context of each educational institution. Higher education institutions also try to align the requirements with accreditation, rankings, and rating frameworks. Finding the right balance between standardization and customization can be a challenge.
